This letter is meant to inform the school community that on 08/17/2017 the Sevastopol School Board adopted policy regarding unpaid lunch account balances. Policy 8500 states students will not be permitted to purchase a meal from the Food Service Department when their account balance reaches -\$50.00. The student will instead be provided an alternative meal until the school collects delinquent lunch accounts.

The district will alert account holders when the account balance approaches -\$25.00. Any student whose account balance is greater than -\$50.00, is subject to action according to the above stated policy. An alternative meal will be respectfully provided to this student and all a la carte sales will be denied until the account is brought into good standing. These meals are not free of charge and the student's account will continue to be charged for each meal. The alternative meals consist of the following items:

### Breakfast:

- 1. 1-33g bowl of whole grain cereal
- 2. 1-cup fruit
- 3. 1- ½ pint carton of fat free white milk

## Lunch:

- 1. 1-sandwich (2oz of sliced cheese with 2 slices of whole grain bread)
- 2. ½ cup fruit (elementary) or 1 Cup fruit (middle and high school)
- 3. 3/4 cup vegetable (elementary) or 1 cup vegetable (middle and high school)
- 4. 1- ½ pint carton of fat free white milk
